As Americans, we share many things "equally".

Take for instance; Freedom of Speech, Freedom of the Press, Freedom to Assemble, and Freedom of Religion.

We equally share the right to bear arms, we are protected from unreasonable search and seizure of an individual or their private property, we cannot face double jeopardy for the same crimes, we have the right against self-incrimination and cannot be imprisoned without due process of law, we have the right to a speedy and public trial, trial by an impartial jury, we have a right to a jury trial, we cannot be held by excessive bail and fines or suffer cruel and unusual punishment.

Our ninth amendment states that listing specific rights in the Constitution does not mean that people do not have other rights that have not been spelled out.

There is always some room for debate regarding the "unspecified" rights. I wish to open a debate regarding the "equal rights" of ownership to public lands.

Let's take public land management and examine the question of "rights". That should make for a nice calm debate.

An overwhelming amount of lands west of the Mississippi are "public lands". States like Nevada and Wyoming are vastly public land. Others have very significant holdings of public lands, but also have significant private holdings.

Back when most of the western states were formed, they had no resources to manage the "public lands", so Uncle Sam established management agencies to oversee the care. In many cases, the promise that the individual states would be allowed to eventually take back the management of those "public lands" when they became able was part of the deal.

Unfortunately, none of the states pursued this return of management rights, so the federal government continues to run things as they see fit... which brings me to the subject of "rights".

In the last 50+ years, our federal lawmakers have made many decisions about how OUR public lands are managed. Many of those decisions have been to the detriment of the local economies and people.

People and entities they belong to have been urging the lawmakers to do things with "public lands". The vast majority of those people have zero personal interest in those lands. 98% of them will never even see the lands they think they have the right to relieve the locals the use of.

In many cases, those local people depend on some of the resources those lands have provided for very long periods, even generations. Resources like:

- Mining interests
- Logging interests
- Recreational interests

What's Your Investment? (Continued)

When it comes to making this kind of decision, my contentions are that the local governments, tribal interests, local user groups, and economies must have a heavily weighted final say in how that land is managed. The local entities have the most lose; therefore, they must have more rights in the final decisions.

- Who is concerned most with the care and stewardship of a local region of public lands?
- Do the people who will never see the land come and pick up trash?
- Will the people who will never see the land replace signage that is vandalized or weathered?
- Will the people who will never see the land repair erosion damage done to a road?
- Will the people who will never see the land care that the area is suffering from drought, insects, or disease enough to do something about it?

We all KNOW who will be the ones who to care about the above. The local people, governments that represent them, and the user groups that USE the lands will have the caring to make sure the best possible management for the most possible users (Multiple Use and Sustained Yield) will be implemented.

Outside interference from special interests has proven to be detrimental to the overall health and welfare of the local areas. The proof is the increase of intensity of wildfires.

When our public lands were healthy, wildfires were somewhat manageable. Since the "Protect and Preserve" management style adopted by the federal government in DC have prevailed, the health of our public lands has continued to diminish to the point that wildfires burn so intensely, nothing survives and the ground is left sterilized.

Wildlife habitat, watersheds, timberlands, air quality, water quality, and recreation are all lost for several years. Extreme water and air pollution will dominate for years. Extreme erosion will prevail. Will the entities from far away do anything to improve the conditions? NO, they will not!!!


The local people and governments will be the ones pressing for the necessary changes in management. The local people and governments will be the ones volunteering to do what is necessary to make those improvements reality.

Therefore, we come back to the main topic. Who deserves more say in the management of public lands? Is it the people and entities that will never see the land or the local people, governments, and user groups?

Do we continue the losing and costly path presently taken or do we begin a new journey?







Northern District Land Use Update by Adam Mehlberg

Canyon Lakes Ranger District:

Multi-district meeting is planned for April 19 at the Supervisors Office in Fort Collins. The meeting will be looking for ways to collaborate on OHV opportunities. Some collaborative work is being done with OHV groups presently. This will be an opportunity to meet as a larger group covering the Arapaho-Roosevelt Forest and Pawnee Grasslands. Goal is to have these larger group meetings on a periodic basis to share information, identify opportunities to enhance OHV road and trail networks, parking and trailheads, signage, saw training and certification, and other ways to take advantage of partnering.

Kelly Flats FR168 - Seasonal closure.

Johnny Park FR118 - Seasonal closure.

Moody Hill FR513 - Seasonal closure.

Crystal Mountain FR344 - Seasonal closure.

Greenridge FR177,319 - Seasonal closure.

Seven Mile FR225 - Open.

Boulder Ranger District:

Dispersed Recreation Site Inventory – In 2018, Boulder Ranger District developed a dispersed recreation site inventory to get a baseline on where campsites are and understand the impacts that are occurring. They have completed approximately 50% of the district and found 600 sites. Some of these are along adopt-a-roads, and will be collaboratively working on whether to rehabilitate some of these, leave some, etc.

2019 Volunteer Service Agreements (VSAs) are being signed by the 4WD clubs that have adopted roads on the Boulder Ranger District.

Bunce School Road FR105 (Backbone ATV) – Bunce School does not seasonally close and will be open through the winter. Peaceful Valley Campground is closed so the only entrance/exit is on the north end. Future projects will involve buck and rail fence repair, sign replacement, road stabilization, and a shooting are cleanup.

Caribou FR505 (NORAC) – Seasonal closure. Caribou usually opens mid summer depending on the amount of snow. Future projects will involve buck and rail fencing in coordination with Boulder Watershed, mud hole repair (possibly corduroy fix), sign replacement, blocking seasonal gate bypass routes.

Kingston Peak FR353 (NORAC/Rising Sun) – Seasonal closure. Kingston usually opens mid summer depending on the snow pack. Future projects include route control along restoration area as well as the large alpine tundra section.



Middle St. Vrain FR114 (Trailridge Runners) -

Seasonal closure. Planned run to review for opening is June 22-23. Hope is to open the road June 23 in the afternoon. Future projects include route control prior to the water holes, entrance obstacle maintenance. Peaceful Valley bridge (first bridge by campground) is scheduled to be replaced after the Labor Day weekend. Middle St. Vrain and Coney Flats will be closed during this project.

Coney Flats FR507 (Trailridge Runners) - Seasonal closure. Will be run the same weekend as the Middle St. Vrain for seasonal opening review. Future projects involve a new "4WD High clearance required" sign, rock garden rocks put back, kiosk panel replacement.

Miller Rock FR252 (Trailridge Runners) - No seasonal closure on Miller Rock, but the snow and ice make this a challenging road to run in the winter. Future projects involve signing roads on the south side of the St. Vrain river, signing that there is no exit to the south, control travel in camping meadow along the river (play routes are being developed).

Jenny Creek FR502.3 (Rising Sun) - Future projects involve post and cable maintenance, campsite restoration.

Rollins Pass Road FR149 (OSCO) - Closed at mile 12. No winter maintenance on mile 1-12. Future project involve Jenny Lake camping area plan, block and re-vegetate bypass at top.

Taylor Mountain FR330 - Open.

T-33 Crash Site FR203 (NORAC)- Seasonal closure. Future projects involve replacing the information sign, fencing repair.

Northern District Land Use Update (Continued)

Gamble Gulch FR411, Moon Gulch FR290, Lump Gulch FR409,410 (Mile Hi, Patrol 19) - New adoption. Future projects involve signing legal roads, blocking illegal routes, fencing restoration area, obstacle bypass blocking.

Lefthand Canyon OHV – Scoping request is now out on the Forest Service web site. www.fs.usda.gov/project/?project=51312 No documents are available yet. Meetings have started. Boulder Ranger District is planning on an interactive map to collect feedback to develop the planning proposals. Survey of existing condition is complete.

T-33 Crash Site FR203 (NORAC) - Seasonal closure.



So, the COA4WDCI is your Association and not some outside entity looking to partner with you or your club.

Lately, Club membership has been on the decline, both at the Club level and membership in the State Association and this situation is not unique to Colorado. There have been some exceptions to this, but the impact of Social Media, especially Facebook Clubs, Groups and Pages has been where many Four Wheelers who in the past were joining clubs are now going. There is no cost or obligation, they can get together for a trail ride, build comradery, get help with technical questions and advise on build and product suggestions for free. In the past, this is what clubs offered and was one of the main reasons people joined. The State Association is trying to combat this thru information sharing and communications tools as to what it takes to keep trails open and maintained in Colorado. Without actual clubs that are registered with the Secretary of States Office, and are in fact legal entities, programs like the Four-Wheel Drive Emergency Assistance Team (FEAT) and the Adopt a Trail program will end. For more than 50 years, our Clubs have supported the National Forrest Service, Bureau of Land Management and Colorado Parks & Wildlife OHV Crews on projects; having a seat at the table when there are discussions about Travel Management Plans, Permitting, Legislation on creating or expanding wilderness area resulting in our trails being closed. It really comes down to numbers, especially when you are dealing with the Federal Government agencies, the State of



Colorado or the local County Board of Commissioners. The more members the State Association represents the louder our voice becomes.

Next comes partnerships. Partnering here in Colorado with organizations like the Colorado Off Highway Vehicle Coalition (COHVCO), Stay the Trail, Western Slope ATV Association, Colorado Snowmobile Association (CSA), Colorado Off Road Enterprise (CORE), Colorado 4x4 Rescue and Recovery (CO4x4RnR) and the Trails Preservation Alliance (TPA), we can be far more successful than tackling our challenges alone. The same is true at the National level. Working with groups like Share the Trail/Blue Ribbon Coalition, Off Road Business Association (ORBA), National Off Highway Vehicle Conservation Council (NOHVCC), Tread Lightly and the United Four-Wheel Drive Association (U4WDA) we can create synergy based on learning what has and hasn't worked in other parts of the country and get their assistance with Federal Agencies.

The bottom line is, we are here to support you and your club and by default the Colorado 4x4 and Off-Road Community at large. 

COLORADO ENACTS LIABILITY IMMUNITY LAW FOR VOLUNTEERS

Meet CO Partner Scott Jones! By: Laura Feist, March 28, 2019

Introducing Scott Jones – Colorado NOHVCC State Partner and Board Member



Scott Jones calls Longmont, Colorado home. He has enjoyed motorized recreation all his life and has been involved in organized OHV activities for over a decade, currently serving as Vice President of the Colorado Off-Highway Vehicle Coalition. Like many OHV enthusiasts, Scott enjoys getting outdoors — with or without

a vehicle. He likes to camp, hunt, hike and has even dabbled a bit in rock climbing. Scott says that many are surprised to learn he is an environmental attorney and that he considers himself an environmentalist. Finally, Scott believes the most important thing an individual can do to create a positive future for OHV recreation is to raise awareness of all the good things the OHV community provides, like volunteers, donations, trail maintenance and positive community involvement.

Colorado Enacts Liability Immunity Law for Volunteers

OHV enthusiasts noticed that it was taking longer and longer for State grant funds to reach them after receiving approval in Colorado. So, a group including Colorado Off-Highway Vehicle Coalition (COHVCO) representatives decided to examine what was creating the delays – and for a way to resolve the problem.

It was found that finding and securing insurance was one significant hold up. So COHVCO representatives did some research and found that Colorado was behind other States in limiting liability for clubs and volunteers. Not only were funds delayed in getting to the ground, there were fears that OHV clubs and volunteers could be liable for damages arising years or even decades after performing trail work that was approved by the agency that managed the relevant land. Further, it seemed that insurance requirements changed annually, making it difficult for volunteers to know how to comply.

Scott and others with COHVCO reached out to officials from Colorado Parks and Wildlife (CPW) – an easy thing to do as a very positive relationship had been established over years. CPW agreed

that it was time to address the insurance issue, so both parties came up with an idea for legislation.

Leaning once again on a relationship that had been developed over time, COHVCO contacted President Pro Tempore of the Colorado Senate, Jerry Sonnenberg to carry the bill. With his leadership, and the support of CPW the legislation passed both the full Colorado House and Senate with a total of two members of either House voting no. That level of support for anything substantive is rare in Colorado, and probably anywhere!

According to the bill summary the new law "strengthens existing legal protections under the federal "Volunteer Protection Act of 1997" and Colorado's "Volunteer Service Act" for individual volunteers and nonprofit entities who build or maintain recreational trails and related facilities pursuant to grants received under Colorado's 'Recreational Trails System Act of 1971.""

Essentially, the law provides an increased level of negligence protections and removes several contracting requirements related to State grants for clubs performing land stewardship activities on public lands.

The positive impacts of the law have been immediate. It is already taking less time for grant funds to get to the ground and it is easier for volunteers to file paperwork on time.

Scott recognized that Colorado was behind most States regarding limiting liability but noted, "Since COHVCO and others maintained positive relationships with agency personnel and with key legislators this process was much easier than it could have been. My recommendation for all OHV enthusiasts is that they cultivate these key relationships, and when you need them it will be easier to succeed."

Adopt A Road - Adam Melberg

Adam handed out the certificates for the clubs that turned in their hours. Reminded everyone to get their hours turned in to him so they can be tracked and that the numbers are always under reported but they can help us when having discussions with land managers and when applying for grants.

Land Use/COHVCO - Scott Jones

Scott provided the following update; Out going Congressman, now Governor, Jared Polis tried to slip legislation into the 2018 Omnibus Bill at the end of the 2018 Congressional Session to close motorized trails near the Continental Divide Trail and it was stopped by COHVCO. Working on stopping a change of road access thru wilderness areas in the San Juan's from the current 300 - 500' to the proposed 50'. Issue being the MVUM's are not always accurate and a 50' corridor for a motorized route (road or trail) is not wide enough to be practical and wouldn't allow for safe areas to pull of trail to park, etc. Working on getting the North Sand Hills Area released from the current Wilderness Study

Area. State issues that were recently taken care of are granting clubs immunity when they are doing volunteer work on trails with the National Forest Service, Bureau of Land Management, State or Counties. Corrected the language in pending legislation that standardized safety standards for ATV's that are allowed on County Roads. Working on Military Vehicle Registration issue that is in the current legislative session (anticipation is the DOD will be selling HMMWV at auction soon and people who buy them will want to register them which you can't currently do in Colorado). Recommendation was to work with the Collector Car Council of Colorado and get a copy of the sample legislation from SEMA. OHV Workshops, last year focus was on trail building and OHV Crew support. This year they are hoping to do two, one on trail building in Gunnison and a Political (meaning for Counties, NFS, BLM, State, etc.) in Salida. Right now, nothing can be scheduled due to the Government shut down. COHVCO does have scholarships available to cover the cost of attending and lodging that the COA4WDCI can use to attend, just need to pay your own way to get there. Endangered Species Act - working with the Western Governors Association to correct legislation via Sit died in committee, but Fish & Wildlife has been making policy changes for listing and removing species from the list that are clearer and easier to work with. One area is setting population goals and once a species hits the goal, they automatically come off the list. Fire Borrowing - In 2017, 52% of the NFS Budget was spent of fighting wild fires. New policy that takes effect in 2020 allows them to go to FEMA for funding and will treat wild fires like other natural disasters. The NFS will keep their crews and continue to fight fires, but it will no longer come out of their operational budget. The OHV Community needs to help monitor this so that the NFS budgets don't take big hits in 2020 and beyond so they can get caught up on all their delayed projects. OHV Sticker Program raises approximately \$4.3 million per year that goes back in to supporting Motorized Recreations. Approx. \$2 million funds the OHV or "Good Management Crews" of which there are 28 such crews working with NFS and BLM. The rest is available for competitive grants which also support Stay the Trail.

United 4WDA – From Jerry Smith, YOU need to be in the land manager's speed dial is most important. That does work

both ways of course. You want to build enough trust and friendship that they will be comfortable calling YOU for advice or help.

Club Membership

No report, but the club listing in the 1st Qtr, January 2019 High Trails Newsletter is correct. We have 20-member clubs, but we do not have an accurate member count because not all the clubs have turned in club rosters.

Stay the Trail & Tread Lightly – Sam Logan gave an update. They attended 64 events in 2018, conducted 12 Stewardship Projects and funded numerous new signs thru a grant from the OHV fund. For 2019 they are working on some new literature and advertising to let people know that there are currently 30 Counties in Colorado that allow ATV travel on County Roads, a listing of what trails street licensed and registered vehicle still need an OHV Sticker for, a new Tundra Brochure to address travel over delicate terrain and some Spanish language version for certain areas in Colorado where it is needed. Molly serves as the events coordinator for Stay the Trail. Colorado Parks and Wildlife released a new mapping application called Colorado Trail Explorer or COTrex which will give you all the trails in Colorado, not just the trails that are on the NFS MVUM's via the Avensa app.

CORE – Marcus Trusty gave an update on what the Colorado Off Road Enterprise was working on. Following the Pike San Isabel Lawsuit and working with NFS on issues related to it. Also working with Gunnison County on their Public Land Initiative which is trying to compartmentalize land use (several of the trails involved also go into Chaffee County). Following the new County Recreational Planning program that was approved in the November Election and how that will affect trails. Spoke a little about 14er Fest and how it is great to get all the users together for a weekend and the project that was done in conjunction with Friends of the Four Mile was a great place to start.

Old Business

COA4WDCI Standard Operating Procedures (SOP) - to reflect dues change from \$15 to \$10 as voted by the Delegates at a previous meeting. (Article II, Section 1 & 2a) — Approved.

Proposed COA4WDCI SOP change setting new quorum requirements to make the meetings official. (Article III, Section 2) – recommendation was made to change the verbiage from "Section 2. A minimum of 20% of the Association member clubs must be represented by delegates to constitute a quorum." To read "Section 2. A simple majority of the Voting Clubs present can hold a meeting and conduct business on behalf of the Association". This proposed change will be discussed and voted on at the 2nd Qtr meeting.

Changes to Statement that appears on the HighTrails.org website to read "The Colorado Association of 4WD Clubs is a not-for-profit (contributions are not tax deductible) umbrella organization for four-wheel drive clubs in the state of Colorado. We began in 1968. We are members of the Colorado Off-Highway Vehicle Coalition, and United Four-Wheel Drive Associations and are voting members of Tread Lightly!

Annually we donate to Colorado based organizations that support the four-wheel drive community such as; Stay the Trail, Four-Wheel Drive Emergency Assistance Team (FEAT), Colorado 4x4 Rescue & Recovery ant the Colorado Off-Road Enterprise (CORE). We also financially support the Colorado Off-Highway Vehicle Coalition Legal Defense Fund (COHVCO) and the Trails Preservation Alliance (TPA) who work to support legislation and legal actions that benefit the four-wheel drive community and oppose those measures that are detrimental to it, and maintaining motorized access to public lands.

We support our clubs' efforts thru the Adopt-A-Trail program with funding for trail project thru our Trails Grant Program. To support the education of our young four wheelers, we give out an annual Scholarship toward post-secondary education.

The Colorado Association is more than a financial supporter of public access. Every year, our clubs do over 10,000 hours of volunteer work on the campgrounds, picnic grounds, hiking trails, and 4WD roads of Colorado. We also participate in the National Trails Day event in June by taking a group of physically challenged people on a 4WD trip into the Rocky Mountains for the day. Many of our Member Clubs with the support of our Associate (Business) Members put on annual events.

The Association meets four times annually, once each quarter, to conduct our association business and to share information about upcoming events. Annually, we also vote for the associations Four-Wheeler of the Year, and Club of the Year for an individual(s) and club(s) that have shown outstanding support for motorized recreation.
