The Expo was apparently a hit with both the participants and the attendees. Estimates agree that the overall attendance was significantly up from previous years. The GMJC is very happy with the outcome and will begin planning for next year soon.










# Association Clubs Doing Their Part to Keep our Trails Open!

Colorado Springs Christian Four Wheelers teamed up with Focus on the Forest and the Pike National Forest Ranger District to pick up trash along Gold Camp Road and do some trail projects up on Forest Service Roads 376 and 379. The volunteers which included some members of the Bearded Bastards and Misfits Facebook Groups picked up over 5,000 lbs. of trash, most of which was from recreational shooters who don't seem to care about trashing our public lands and some other items like a truck bed camper that someone abandoned in the woods. Members of CSC4W's also helped install over 200' of fence along the entrance of Bull Park and dragged numerous downed trees to block off illegal off trail areas on 376 and 379









June 22, 2019 Bighorn 4x4 of Colorado Springs took some volunteers from Rocky Mountain Kids to pick up trash at the entrance to Eagle Rock and Saran Wrap off of Gold Camp Road. Considering this whole area was cleaned just cleaned two weeks prior, they filled 12 fifty-gallon trash bags with more trash from careless target shooters. The group then ran Eagle Rock, their adopted trail and did some maintenance along the way in the hail, snow and rain!





June 23, 2019 Mile High Jeep Club was up on the Sidewinder Trail north of Kremmling working with the local Bureau of Land Management Office clearing the entrance of the trail and installing a 200' post and cable fence to keep people from going off trail and up a hill before the "Gate Keeper". The County Road and trail itself were extremely muddy so the decision was not to run the trail that day until it dried out a little to avoid damage. While the heaving lifting was being done, our youngest volunteer and future Paleontologist collect bones from the area and with the help of the resident Anthropologist tried to determine what animals they all came from.







June 30, 2019 Members of the Colorado Off Road Enterprise (CORE) teamed up with Mile High Jeep Club and the Colorado Association of Four Drive Clubs Board of Directors to clear over a 1,000' of avalanche debris up on Tin Cup above the town of St. Elmo. The trail is now open to the tree line on the east side, however snow pack and a slide up on the switchbacks below the pass will keep the pass itself closed until more snow melts and the condition of the trail can be assessed. Once the work there was done, CORE Members headed up Grizzly Lake to assess the condition of the trail, cleared some small areas up to the tree line and then found a large avalanche debris field just below the lake that will be dealt with at a future date.

## Northern District Land Use Update by Adam Mehlberg

#### **Canyon Lakes Ranger District:**

Multi-district meeting was held April 19, 2019 at the Supervisors Office in Fort Collins. The meeting initiated communication between the motorized groups and the Arapaho-Roosevelt National Forest and Pawnee Grasslands personnel. We will have these larger group meetings on a periodic basis to share information, identify opportunities to enhance OHV road and trail networks, parking and trail heads, signage, saw training and certification, and other ways to take advantage of partnering. The next meeting will be at the Boulder office on July 23, 2019.

Kelly Flats FR168 - Open

Johnny Park FR118 - Open

Moody Hill FR513 - Seasonal closure.

Crystal Mountain FR344 - Seasonal closure.

**Greenridge FR177,319 -** Seasonal closure.

Seven Mile FR225 - Open



Dispersed Recreation Site Inventory – In 2018, Boulder Ranger District developed a dispersed recreation site inventory to get a baseline on where campsites are and understand the impacts that are occurring. Using this information they have had three projects around the district to rehabilitate and consolidate campsites. The most recent one was Gordon Gulch on June 15, 2019.

2019 Volunteer Service Agreements (VSAs) have been signed by the 4WD clubs that have adopted roads on the Boulder Ranger District.

**Bunce School Road FR105 (Backbone ATV)** – Bunce School does not seasonally close. Future projects will involve buck and rail fence repair, sign replacement, road stabilization, and a shooting are cleanup.

**Caribou FR505 (NORAC)** – Still seasonally closed. Review will be on July 6-7, 2019. Future projects will involve buck and rail fencing in coordination with Boulder Watershed, mud hole repair (possibly corduroy fix), sign replacement, blocking seasonal gate bypass routes.

**Kingston Peak FR353 (NORAC/Rising Sun)** – Still seasonally closed. Planned review date for opening is July 13, 2019. Future projects include route control along restoration area as well as the large alpine tundra section.

**Middle St. Vrain FR114 (Trailridge Runners)** – SStill seasonally closed. There is too much snow on the upper part of the road. Project will be June 22-23 to do what maintenance on lower sections. Projects include route control prior to the water holes, entrance obstacle maintenance. Peaceful Valley bridge (first bridge by campground) is scheduled to be replaced after the Labor Day weekend. Middle St. Vrain and Coney Flats will be closed during this project.



**Coney Flats FR507 (Trailridge Runners)** - Still seasonally closed. Will be run the same weekend as the Middle St. Vrain to do maintenance on lower section. Future projects involve a new "4WD High clearance required" sign, rock garden rocks put back, kiosk panel replacement.

**Miller Rock FR252 (Trailridge Runners) -** No seasonal closure on Miller Rock. Working on signs for roads on the south side of the St. Vrain river. Need to control travel in camping meadow along the river (play routes are being developed).

**Jenny Creek FR502.3 (Rising Sun) -** Future projects involve post and cable maintenance, campsite restoration.

**Rollins Pass Road FR149 (OSCO) -** Closed at mile 12. No winter maintenance on mile 1-12. Future project involve Jenny Lake camping area plan, block and re-vegetate bypass at top.

**Taylor Mountain FR330 - Open.** 

**T-33 Crash Site FR203 (NORAC) -** Still seasonally closed. T-33 information sign has been replaced. Will be reviewed June 23, 2019. More fencing repair and route control will be needed.

**Gamble Gulch FR411, Moon Gulch FR290, Lump Gulch FR409,410 (Mile Hi, Patrol 19)** - New adoption. Future projects involve signing legal roads, blocking illegal routes, fencing restoration area, obstacle bypass blocking.

**Lefthand Canyon OHV** – Scoping request is now out on the Forest Service web site. https://www.fs.usda.gov/project/?project=51312 No documents are available yet. Meetings have started. Boulder Ranger District is planning on an interactive map to collect feedback to develop the planning proposals. Survey of existing condition is complete.





#### Adopt-A-Road / Volunteer Projects, by Adam Mehlberg

There is still time to do planning with the land managing agencies on your Adopt-A-Road projects. The late arrival of summer has delayed the melt out of the snow pack and kept some 4WD roads closed later into the season. It can be hard to get in contact with the public lands managing agencies, so persistence is required. If you have a good working relationship with the agencies it is important to maintain the communication.

Hours reported this year are shown in the summary next page.

#### \*\* Deadline for 2019 hours is September 15 \*\*

Any hours reported after this date will go into 2020 and will be reported to the managing agencies late, which will not help them in their annual reports.

# Remember that the drive time to and from the project counts.

You can document hours your club members meet with the public land agencies to do planning for on the ground projects, or time spent interfacing with the public as a volunteer for the Forest Service or BLM. You may also document hours for hosting 4WD roads and running trail patrols.


